1 | DATES

The 7th ECOCUP Green Documentary Film Festival will take place in Moscow in February 2016.

The deadline for all applications is November 1 2015.

2 | FESTIVAL'S MISSION

ECOCUP Green Documentary Film Festival's aim is to present and promote movies and videos that deals with issues and problems related to the environment.

The submission of the entry-form constitutes the acceptance of all rules hereby described.

The films may be sent in the following ways:

1. Passworded VIMEO link with ability to download the HD quality file
2. Entrants may ship the DVD or BlueRay by post/courier.

5 | FILMS ADMITTED TO THE FESTIVAL

The Festival will select films admitted at 7th ECOCUP to its final judgement.
The authors admitted to the competitions will be informed within November 1 2015.

The festival does not require the first preview of the film. It requires, however, to not screen the film throughout Russia in months of 2016.

The application to the Festival automatically implies the authorization that a max of 3 minutes of an extract of the film may possibly be broadcasted on TV for promotional use only. (10% of the lenght for the short films).

6 | COSTS

Registration is free of charge.

The shipping costs of all material entered are to be covered by the entrants.

Festival does not pay the screening fee.

7 | HOSPITALITY

The Festival will encourage the participation of film directors and other guests (journalists, professionals, film festival's representatives). In some cases Festival can cover the travel costs to Moscow. Festival also can support the guests with accomodations in Moscow.

8 | TRANSLATIONS

All films in foreign languages will be subtitled to Russian language or simultaneously translated.

All Festival documents will be published in Russian.

9 | JURIES and PRIZES

Official prizes will be assigned by qualified juries, each composed of at least three members, appointed by the Festival's Direction. Prizes will be announced in November, 2015.

10 | FESTIVAL TOUR

Selected films may be screened and promoted during other editions of the ECOCUP Festival in Russian cities through the year, previous common agreement with the copyright owner.

ECOCUP Festival editions in other cities are usually small non-commercial events made by the means of local volunteer. You may agree or not agree for the edition screening, but we usually encourage the participants to do it, as for small Russian cities ECOCUP is rare end unique event. Every screening will be discussed with you in advance.

ECOCUP Green Documentary Film Festival also participates in number of non-profit and non-commercial environment-related educational events throughout the year. You may agree or not agree for these events screening. Every screening will be discussed with you in advance.

In case of participation in commercial event Festival makes sure that the event pays the screening fee to the Film. Opportunities of such a screenings will be discussed with you.
